#### **4.0 OPENING OF TENDER:**

The tender will be opened on **Dt. 14/03/2018** at **Time 19:30 Hrs.** at IE (I) South Gujarat Local Center (SGLC), Mahida Bhavan, Opp. SVNIT, Ichchhanath, Surat-Dumas Road, Surat 395007.

Intending bidders or their representative who wish to participate in tender opening can remain present at the address above on the due date and time, mark their presence or participate in tender opening. Only one representative of each firm will be allowed to remain present.

### **5.0 GENERAL INSTRUCTIONS:**

- a) The cost of tender document will not be refunded under any circumstances.
- b) EMD with validity of 120 days or more from Scheduled Bank / Nationalized Bank in the form specified in tender document only shall be receipted.
- c) The offer shall be valid for 30 days from the last date of submission of tenders.
- d) Building and other construction workers welfare cess 1% will be recovered from the bill of work done.
- e) Conditional tender will be disqualified and liable for outright rejection.
- f) IE(I) SGLC reserves the right to accept responsive offer based on evaluation of tender and reject any or all tenders without assigning any reason thereof.
- g) The notice shall form a part of contract document.
- h) The interested tenderers are advised to read carefully the "Instruction" and "Eligibility Criteria" contained in the tender documents.
- i) The right to accept or reject any tender remains with The Chairman, IE(I) SGLC with/without disclosing any reason thereof.
- j) EMD and Tender fee shall be submitted as mentioned above.
